Massachusetts Youth Soccer will be your complete source for hotel accommodations for all tournaments held at our Massachusetts Youth Soccer Fields at Progin Park in Lancaster, MA. We want to make it convenient for you and your team, as well as, make accommodations available to all teams.

WITH OUR DESIGNATED HOTELS:

- ✓ We can have room nights “blocked” for our out-of-area teams.
- ✓ We consider location and proximity to our complex.
- ✓ We carefully approve our hotels with the same degree of professionalism, attention to detail and quality service that our Massachusetts Youth Soccer staff and tournament hosts uphold.
- ✓ And by using our designated hotels, we can offer our “*Act of God*” Clause. Should the tournament be cancelled for reasons beyond the Tournament Host’s control, all reservations will be released at no charge prior to the team’s arrival.

Our policy requires all teams to make their hotel reservations for their entire team and teams are not allowed to book directly with any hotel. Massachusetts Youth Soccer will make your reservations based on the information provided on your online Hotel Registration Form. Some hotels may require a rooming list and/or contract, others may not. In order for parents to receive the Massachusetts Youth Soccer team rate, the team representative must book the rooms as part of their block.

PLEASE READ CAREFULLY

All reservation requests will be made through Lori Jiménez, the Massachusetts Youth Soccer Events and Programs Coordinator. Reservations are subject to availability and may be changed without notice. Acknowledgements will be sent after each reservation booking, modification and/or cancellation. Please review acknowledgements carefully for accuracy. TERMS/CANCELLATION POLICY

All teams must book their hotel reservations 30 days prior to the first day of the tournament. Rooming list and valid credit card(s) is required to guarantee the reservation(s). All hotels have a five business day individual cancellation penalty period and a 30-day team cancellation penalty period unless otherwise noted (team cancellation defined as 50 percent or more of a team’s rooms being cancelled). Should the tournament be cancelled for reasons beyond the Tournament Host’s control, all reservations covered under our “*Act of God*” Clause will be released at no charge prior to the team’s arrival. Teams are not confirmed at their Massachusetts Youth Soccer contracted hotel until the team representative has received confirmation number(s). Complete terms/cancellation policy will be sent to the team representative with hotel confirmation. Teams are responsible for coordinating their own meeting space and any and all of their own meal accommodations.
